


Project Preparation and Financing in the Water, Climate and Development Programme

The Water, Climate and Development Programme (WACDEP), an African Ministers' Council on Water programme implemented by the Global Water Partnership and partners, aims to integrate water security and climate resilience in development planning processes, build climate resilience and support countries to adapt to a new climate regime through increased investments in water security across the continent. In order to promote water as a key part of sustainable regional and national development and contribute to climate change adaptation for economic growth and human security, four components, composed of eight respective work packages, were designed to address outcome challenges.

Component One, *Investments in Regional and National Development*, includes four different work packages. Work Package 1 sought to support River Basin Organisations and governments in developing tools and investment options that integrate water security and climate resilience. In Work Package 2, the project supported national organisations in developing legal frameworks, sectoral and development plans that would facilitate water security and climate resilient projects. Lastly, in Work Package 3, organisations were supported in the development of investment strategies that

would integrate water security for climate resilience. Work Package 6 and 7 on capacity development and knowledge management are the key enabling activities in delivering the work. Work Package forges a partnership approach an added value that the Global Water Partnership brings in project development.

With support from the Infrastructure Consortium for Africa (ICA), Work Package 4 capitalised on the three previous streams to support 20 institutions at regional and national levels in Africa in project preparation and financing.



This work assisted national and regional institutions in project preparation by: (1) providing capacity development, (2) assisting in project screening and definition, (3) ensuring multi-sector engagement and consultation, (4) developing financing reviews and (5) producing concept notes.



KEY RESULTS FROM WACDEP PROJECT PREPARATION AND FINANCING

The project preparation work supported by ICA, built on the platform provided by GWP through its extensive partnership, and assisted project development teams in engaging, defining and

developing robust, bankable projects. As the early stages of conceptualisation of projects receive little attention or focus by the funders, much of this work focused on early-stage project development.
