Cap-Net is UNDP's global network for capacity development in sustainable water management within the Global Water and Oceans Governance Support Programme.




The Global Water Partnership's vision is for a water secure world. Our mission is to advance governance and management of water resources for sustainable and equitable development.

THE CHALLENGE

By **2050**, more than **5 billion people** could **suffer** from **water scarcity**, threatening 45 percent of the world's economy. The water crisis negatively affects health, hunger, pollution, poverty, economic growth, biodiversity, climate change and much more. Addressing water resources management in an integrated way lies at the heart of finding solutions to today's sustainable development challenges.

However, in 2017 country implementation of SDG indicator 6.5.1 (the degree of implementation of Integrated Water Resources Management) was only at 49% worldwide, and 60% of countries are currently not likely to reach the global target by 2030, pointing to the clear need to ACCELERATE PROGRESS.

THE SDG 6 IWRM SUPPORT PROGRAMME

This programme assists governments in designing and implementing country-led responses to the Sustainable Development Goals (SDGs) indicator 6.5.1, the degree of implementation of IWRM, as an entry point to accelerate progress towards the achievement of water-related SDGs and other development goals, in line with countries' national priorities.

Under the guidance of the UN Environment Programme (UNEP) and coordinated by the Global Water Partnership (GWP) in collaboration with UNEP-DHI Centre and Cap-Net, the Support Programme brings together a unique blend of partners in each country, representing governments, civil society, academia and the private sector, in the spirit of SDG 17 on Partnerships for the Goals.

IDENTIFYING CHALLENGES

Stage 1 aims to strengthen national monitoring and reporting frameworks on SDG 6.5 on IWRM, **identifying critical areas** for attention that hinder **IWRM** at the national level. This is achieved through the completion by national governments every three years of a survey on **SDG** indicator 6.5.1, issued by UNEP as the custodian agency, to allow countries to evaluate their **implementation** of IWRM, in a multi-stakeholder environment, gathering different perspectives to represent the range of water-related challenges and opportunities.



WHERE WERE TO GO

FORMULATING RESPONSES

Having identified key national challenges to IWRM, Stage 2 aims to facilitate a **government-led multi-stakeholder process** to formulate and prioritise relevant responses. The result is an **IWRM Action Plan** and **road map** to systematically guide the implementation of solutions to the country's priority IWRM challenges.


IMPLEMENTING SOLUTIONS

In Stage 3, the Support Programme assists countries in implementing the **IWRM** actions aimed at achieving SDG 6 and other water-related goals through a series of transformative actions which help countries to advance in a measurable way towards their **SDG targets**, and which together constitute an attractive water security **investment portfolio**.



THE ACHIEVEMENTS SO FAR

The Support Programme has assisted more than **70 countries** in reporting progress on **IWRM**, bringing together more than **3,000 stakeholders**, and facilitating the creation of **150+** concrete **actions** supporting **IWRM** implementation in **10 countries**.









By **2025**, we plan to support the creation of IWRM action plans in at least **40 countries** and develop funding schemes to support the implementation of IWRM solutions globally.
