







Advisor for Water & Peace, Stockholm International Water Institute (SIWI) and the International Centre for Water Cooperation (ICWC)

- Martina has 15 years of experience working with dialogue facilitation, conflict resolution, political and security analysis, including practical work in the field and informal diplomacy processes. Her main focus is on water diplomacy and water cooperation, climate and security, dialogue facilitation, incentives, and third party involvement in negotiation processes.
- Martina's book Using Carrots to Bring Peace? Negotiation and Third Party Involvement (World Scientific, 2016) focuses primarily on the effectiveness of aid conditionality and other external tools that third parties – from states and regional organizations to NGOs – bring to the table in peace negotiations. In 2019, Martina was the editor of Special Issue on Water Diplomacy of the Journal of Hydrology.
- Martina holds a PhD degree in International Relations and is a member of the Scientific Programme Committee (SPC) of the World Water Week and Associated Research Fellow at the Institute for Security and Development Policy (ISDP) in Stockholm.
- The art of diplomacy is about finding sustainable solutions based on cooperation and reframing of zero-sum thinking about the conflict narrative. One of the most pressing issues in water diplomacy is therefore how to build sufficient political will to support necessary compromises needed for cooperation without politicizing the disputed issue.



- Aaron T. Wolf, PhD, is also a professor at IHE-Delft since 2020, a
 Member of the Board of the International Centre for Water
 Cooperation (ICWC) since August 2021, and a trained water
 conflict mediator and facilitator. His research and teaching focus
 is on the interaction between water science and water policy,
 particularly as related to conflict prevention and resolution.
- He has acted as consultant to US Government agencies, the World Bank, and several international governments and organizations on various aspects of transboundary water resources and dispute resolution. All told, he is (co-)author or (co-)editor of seven books, as well as close to 100 journal articles, book chapters, and professional reports on various aspects of transboundary waters, from the local scale to the international.
- He directs the Program in Water Conflict Management and Transformation, through which he has offered workshops, facilitations, and mediation in basins throughout the world. He also facilitates in faith and interfaith communities based on the work of his most recent book, The Spirit of Dialogue: Lessons from Faith Traditions in Transforming Conflict (Island Press, 2017).














H.E. Hassan Janabi

- A frequent guest speaker at major international and UN meetings in the Middle East and beyond, H.E Hassan Janabi provides insightful views on issues related to human and natural resources development in the Western Asian region.
- H.E. Janabi is also a writer and a lecturer on socioeconomic development in the Middle East focusing on food and water security, poverty reduction, rural development, water scarcity, ecosystem restoration and preservation, land conservation, climate change adaptation, international law and shared water resources.

Former South Africa Chief Delegate and Permanent Representative on the Lesotho Highlands Water Commission (LHWC)

- Dr Zodwa Dlamini (South Africa) is a seasoned international transboundary water management specialist, development professional, and senior infrastructure projects manager.
- As the former South Africa Chief Delegate and Permanent Representative on the Lesotho Highlands Water Commission (LHWC) for 11 years, she oversaw the Lesotho Highlands Water Project (LHWP) and its implementation. The LHWP is a binational project between the government of the Republic South Africa and the Kingdom of Lesotho responsible for delivering water from the highlands of Lesotho to South Africa and utilising the water delivery system to generate 72MW hydro-electric power for the Kingdom of Lesotho.
- LHWP is Africa's largest water transfer scheme to date. Dr Dlamini further ensured that gender policies in the LHWP are intentional and decisive in matters of gender inclusivity and participation of women. It was during her tenure when the LHDA first appointed a woman Chief Executive Officer (CEO) in over 20 years of its existence.










Management & Conflict Management

- Managers reported that they routinely spent 50-100% of their time managing water conflict
- The higher the management level, the more time was spent in managing conflict
- Training across levels was sporadic
- Is conflict rewarded?

GETTING TO "YES"


- Separate the PEOPLE from the problem

- Insist on Objective CRITERIA



WATER DIPLOMACY NEGOTIATING TRANSBOUNDARY AGREEMENTS

- When negotiating the Lesotho Highlands Water Project (LHWP) Phase II between the Kingdom of the Government of Lesotho and the Republic of South Africa, the following are some of the pillars employed:
- LHWP Treaty of 1986 between South Africa and Lesotho
- SADC Protocols 2000
- International Laws
- Transparency at all times
- Negotiating in Good Faith
- Ensuring that both countries achieve their needs through compromise
- All concluded agreements by various negotiating teams to be signed off and submitted to script writers
- Adoption of Code of Conduct











Map Showing Origins Of The Orange And Vaal River

CONCLUSION

- LHWP Phase II was successfully negotiated and entered into agreement by the two governments of the Kingdom of Lesotho and the Republic of South Africa.
- LHWP Treaty of 1986 between South Africa and Lesotho stated that only phase I of the LHWP is covered by the current treaty and all subsequent Phases to be negotiated separately. This also shows Good Faith
- In terms of the SADC Protocols 2000 and International Water Resources Laws countries upstream were informed prior to the implementation of the Phase II negotiations and reports shared on progress.
- Transparency at all times: Feasibility studies and other research studies were jointly conducted by the two countries through the commission to ensure transparency.
- Negotiating in Good Faith; this was the foundation of the negotiations even when sometimes teams were discouraged and became despondent, the rallying factor was GOOD FAITH
- Ensuring that both countries achieve their needs through compromise and transparency
- Lessons learned from LHWP Phase I ensured that upfront agreements on operations are finalised before entering the real negotiations. For instance, the issue of all concluded agreements by various negotiating teams to be signed off and submitted to script writers was a case in point. This further ensured that there was no waste of time with people reneging from the agreements.
- Adoption of Code of Conduct ensured that all parties respect the process irrespective of their economic standing.








