# **Annual Financial Report 2008**

# **Executive Summary**

#### The network

The Global Water Partnership (GWP) is a non-profit action network with a focus on water resources management and development. It is a multi-donor funded network focusing on facilitating and supporting countries in social change processes for the sustainable management of their water resources. GWP was established in 1996 as a multi-stakeholder partnership of government agencies, public institutions, private companies, professional organisations, multilateral development agencies and others and provides a mechanism for harmonization across different national actors and internationally across different external support agencies.

The GWP provides a platform for multi-stakeholder dialogue at global, national and local levels in thirteen regions: Southern Africa, Eastern Africa, Central Africa, West Africa, the Mediterranean, Central and Eastern Europe, Caribbean, Central America, South America, Central Asia and the Caucasus, South Asia, Southeast Asia and China. The GWP Secretariat is located in Stockholm, Sweden.

#### Organisation

GWPO is managed by an Executive Secretary who is answerable to the Steering Committee (SC). The Steering Committee engages in policy oversight and approves the work programme and budget of the organisation. Steering Committee members serve in their personal capacity. The Steering Committee and its Chair are appointed by the Sponsoring Partners, comprising the ten founding members of the GWPO. The Steering Committee is chaired by Letitia A. Obeng, took up her appointment on January 1, 2008.

The GWPO Secretariat – established as an intergovernmental agency in Sweden as the Global Water Partnership Organisation (GWPO) – had a staff of sixteen supported by core funds in December 2008; two staff seconded by the French Government; and the equivalent of four full time staff supported by funds provided through restricted programmes – a total of 20 staff and two secondments.

#### THE PROGRAMME

The Global Water Partnership's vision is for a water-secure world. Its mission is to support the sustainable development and management of water resources at all levels.

GWP's action network provides knowledge and builds capacity to improve water management at all levels: global, regional, national and local. The Partnership helps

countries to connect water resources planning and operations at different scales – transboundary, regional, basin, national and local – so that actions are coherent and sustainable. Instead of taking the traditional development approach in which projects are often not connected, GWP works with numerous key stakeholders to design strategic approaches to improving water management. This builds local capacity in the long term. GWP does not operate alone; indeed its networking approach provides a mechanism for coordinated action and adds value to the work of many other key development partners.

2008 was a year of transition for GWP. A major effort was expended in developing a new global strategy for the period 2009 – 2013. It was also a year of action and progress at the global and regional levels and a period of change for the Stockholm Secretariat: in addition to significant personnel changes, there is a new momentum around strengthening the Network Operations and Communications functions to support the Regions more effectively.

During 2008, GWP made many strides in its collaborative efforts to remain at the forefront of global thinking on water management and its implications for development issues. Many of the challenges that will be addressed by the Network's new strategy have been given a solid foundation in 2008. Climate change adaptation, infrastructure and financing, urban and basin water management and further work on national water resource management policies and practices are all continuing whilst there has been a renewed focus on knowledge management, in particular though improvements to the potential of the IWRM ToolBox, the key GWP tool to enable practitioners to learn from practice-based tools.

GWP has also strengthened its operational links with the International Network of Basin Organizations (INBO) both globally and at regional levels. GWP is also building stronger alliances with strategic Partner organisations, such as UN-Water, the European Union Water Initiative, CapNet, the Associated Programme on Flood Management, the World Water Council and others and is building new alliances with Partners such as the Cooperative Programme for Climate and Water and the Water Integrity Network.

At the regional level, GWP through its regional and country water partnerships continue to make progress in advocating and supporting sustainable development and management of water resources. GWP Partners form 13 Regional Water Partnerships (RWPs) and more than 70 Country Water Partnerships (CWPs). These are neutral and inclusive platforms for dialogue and facilitating change processes. The Regional and Country Partnerships manage and govern themselves, and convene stakeholders to address their region- or country-specific problems. They bring about solutions that are both tailored to local conditions, and informed by local experiences and good practices from across the network. A high level of achievement is evident in the 13 regions. More details are available in the Annual Report of "GWP in Action 2008" which is published separately.

#### **FINANCE**

Core contributions

The number of donors channeling funds through GWPO during 2008 were 14 (2007 14 donors) The donors, Canada, Denmark, European Commission, Finland, France, Germany,

Netherlands, Norway, OIEAU, Spain, Sweden, Switzerland, United Kingdom, and U.S.A contributed a total of USD 9.7 million (9.5M 2007) in core funding. The core funding through the GWPO Secretariat during the years 2004–2008 remains at a stable level of USD 9-10 million. The core contributions for 2009 are estimated to remain at the same level.

#### Locally raised funds

The regions are encouraged to raise their own funds. During 2008, USD 2.4 million was raised by the regions/countries, an increase of USD 0.6 million compared to 2007.

#### In-Kind contributions

The contributions reported in the Annual Financial Report do not include funds provided in-kind from governments, organisations or individuals. The in-kind contributions are not fully captured but should be recognized as a substantial source of funding. France, as one example, has supported GWPO Secretariat with secondment/s since 2002.

#### Programme funding

Funds for Programme (restricted funds) activities were provided by the donors Canada, European Commission, Finland, Netherlands, United Kingdom, and U.S.A. The activities at regional as well as country level accounted for USD 3.1 million during 2008. The 2009 Programmes activities are estimated to increase slightly to USD 3.3 million.

#### Outstanding issue UNDP

GWPO received in February 2006 a claim from UNDP of USD 1,228,335. The claim is according to UNDP for expenditures paid by UNDP in 2001 on behalf of GWPO. GWPO has not acknowledged the claim as the audited Annual Reports 2001–2004 do not include a liability to UNDP of this amount. Recorded as a liability in the Annual Financial Report is an amount of USD 525,549 and USD 702,786 is noted as contingent liability. GWPO is making every effort to resolve this matter in consultation with all parties involved. By March 2009 no progress has been made to resolve the issue.

#### EU Water Initiative Finance Working Group

The EU Water Initiative Finance Working Group (EUWI FWG) is hosted by GWPO and GWPO provides financial and administrative management.

GWPO administers the finances as agreed with DFID in May 2006. DFID has committed an amount of not exceeding GBP 500,000 for the operations of EUWI FWG 2006 to 2009 work programme. The Secretariat for EUWI FWG consisted during 2008 of two staff members, one part time Project Coordinator and a part time Chair.

The European Commission granted in 2007 support to the Finance Working Group of the EU Water Initiative for actions in ACP countries. The project started 1 January 2008 and is co-financed with funds from DFID, Euro 340,000, and has for a 36 months period a budget of Euro 740,000. Income and expenditures for the project, Euro 156,431, are reported in the GWPO Annual Financial Report.

EUWI FWG received in addition to the EC project funds contributions in 2008 from DFID and SIDA of Euro 65,589.

#### Notes

#### Accounting principles

The Annual Report has been prepared on a going concern basis as well as an accrued basis according to the principles below.

The generally accepted accounting principles in Sweden form the basis for the GWPO accounting policy. The Swedish accounting policy is not followed for fixed assets (see below), the currency rate reserve is not in accordance with the Swedish accounting principles (see below), and the specification of salaries and other staff costs should according to Swedish principles be more detailed.

#### Contributions

Contributions are accounted for on an accrual basis when GWPO becomes entitled to the contribution.

**Core** contributions are unrestricted contributions to be used for any of GWPO's purposes within the GWP Strategy and Work Plan.

Programme contributions are restricted contributions with specific restrictions issued by the donors.

All contributions for Programme activities above the level of expenditures for the financial year are booked as advances from Donors.

All contributions are shown at gross value.

#### In-kind contributions

In-kind contributions are, according to Swedish accounting principles, not to be reported in the Income Statement. GWPO has received in-kind contributions from France at an estimated value of USD 300,000 during 2008.

#### Fixed assets

GWPO's policy is to charge office equipment within the year in which it has been incurred. Office equipment of USD 17,151 (2007 USD 67,118) purchased in 2008 is recorded as expenditures. Accumulated purchase of office equipment since 1 July 2002 is USD 276,733.

#### Currencies

The GWPO accounting is undertaken in Swedish Kronor (SEK). For reporting purposes the currency of the United States Dollar (USD) is used. The rate of exchange SEK/USD ruling at the balance date is used for all assets and liabilities. The average exchange rate SEK/USD for the financial year is used for all contributions and expenditures.

#### Leased assets

All lease agreements, regardless of whether they are financial or operating in nature, are accounted for as rental agreements (operating lease agreements).

The leasing fee is expensed over the full period of the lease on a linear basis.

#### Currency rate fluctuation reserve

The Currency rate fluctuation reserve was introduced in 2005 as a facility to overcome distortions caused by fluctuations in the exchange rate SEK and other currencies in which GWPO holds bank accounts. The reserve includes exchange rate gains and losses on bank balances only. The reserve could never show a negative value.

#### Receivables

On the basis of individual assessment, receivables are reported at the amounts which they are anticipated to be received.



#### Pension costs

Pension premiums for international staff, calculated as a percentage of gross salary, are deposited semi annually at AMFIE ( Association Mutualiste des Fonctionnaires des Organisations Intergouvernementales, Luxembourg).

Unpaid balance by the end of 2008 is Euro 1,804.

Pension premiums for Swedish staff, calculated as a percentage of gross salary, are paid monthly to SEB Trygg Liv (Sweden). No unpaid balance by the end of 2008.

#### Liabilities

Liabilities are reported at their nominal amounts.

#### Cash flow statement

The statement is prepared in accordance with the indirect method. The cash flow only includes transactions which generated ingoing or outgoing payments.

## Audit report

## **Global Water Partnership Organisation**

We have audited the annual accounts, the accounting records and the administration of the Steering Committee's and the Executive Secretary of Global Water Partnership Organisation for the year 2008. These accounts and the administration and the application of the stated accounting policies, when preparing the annual accounts, are the responsibility of the Steering Committee and the Executive Secretary. Our responsibility is to express an opinion on the annual accounts and the administration based on our audit.

We conducted our audit in accordance with generally accepted auditing standards in Sweden. Those standards require that we plan and perform the audit to obtain reasonable assurance that the annual accounts are free of material misstatement. An audit includes examining, on a test basis, evidence supporting the amounts and disclosures in the accounts. An audit also includes assessing the accounting principles used and their application by the Steering Committee and the Executive Secretary and significant estimates made by the Steering Committee and the Executive Secretary when preparing the annual accounts as well as evaluating the overall presentation of information in the annual accounts. As a basis for our opinion concerning the administration we have examined significant decisions, actions taken and circumstances of the organisation in order to determine whether any member of the Steering Committee or the Executive Secretary has acted in contravention of the Memorandum of Understanding on the establishment of the GWPO or the Statutes. We believe that our audit provides a reasonable basis for our opinion set out below.

The annual accounts have been prepared in accordance with the stated policies and, thereby, give a true and fair view of the organisation's financial position and results of operations in accordance with generally accepted accounting principles in Sweden. The executive summary is consistent with the other parts of the annual accounts.

The Steering Committee and the Executive Secretary have in our opinion acted according to the Memorandum of Understanding on the establishment of the GWPO and the Statutes.

Without qualifying my opinion above I want to draw the attention to the executive summary and note 24 of the annual report which include information that there is a dispute with an earlier supplier who has lodged a claim of USD 1,228,335. The background to the claim is not clear to the organisation so the annual report only includes a liability of USD 525,549. The difference of USD 702,786 is, however, neither of any major significance to the organisation's going concern nor for the annual report as a whole.
