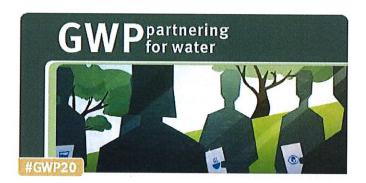

# **Executive Summary**

#### The network

The Global Water Partnership (GWP) is a non-profit global action network with a focus on building water security at country, regional, and global levels. GWP was established in 1996 as a multistakeholder partnership of government agencies, public institutions, private companies, professional organisations and multilateral development agencies and has been growing rapidly. It works to facilitate dialogues and to support countries which are implementing processes for the sustainable management of their water resources. GWP is funded by a range of Financing Partners.

GWP provides a neutral platform for multistakeholder dialogue in 13 regions of the world, namely: Southern Africa, Eastern Africa, Central Africa, West Africa, the Mediterranean, Central and Eastern Europe, Caribbean, Central America, South America, Central Asia and the Caucasus, South Asia, Southeast Asia, and China.

Currently, the Network comprises 13 Regional Water Partnerships, 86 Country Water Partnerships, and 3,427 Partners located in 183 countries.



## Organisation

The GWP Organisation (GWPO) is managed by an Executive Secretary, who reports to the Steering Committee. The Steering Committee is the executive body of the Organisation. It develops, steers, and organises the work of the Organisation and guides the co-operation among the Partners within the Network. It provides policy oversight and approves the work programme and budget. Steering Committee members serve in their personal capacities. The Steering Committee and its Chair are appointed by the Sponsoring Partners, comprising the ten founding members of the GWPO.

The GWPO was established as an intergovernmental organisation in 2002 and is hosted by the Government of Sweden. The GWP Global Secretariat had an average of 25 staff supported by core funds during 2016, one staff supported by earmarked funds, and one staff seconded by the French Government.

# **The Programme**

#### GWP at mid-Strategy

2016 marked the mid-point of the *GWP Strategy Towards 2020: A water secure world*. GWP's practice has been to assess progress achieved mid-way through its strategy periods and to take the lessons learned to guide implementation during the second half. Below are selected highlights of achievements during 2014-2016.

#### Results in policy and practice

**Improving water governance:** Since 2014, GWP influenced to varying degrees more than 120 key water governance outcomes.

**Leveraging investments:** In Africa, almost EUR 20 million has been leveraged through GWP support to institutions such as national ministries, local governments, and river basin organisations.

Enhancing climate resilience: Continuous work in climate advocacy coupled with results achieved through the Water, Climate, and Development Programme and Integrated Drought Management Programme projects has resulted in a well-funded and respected climate portfolio. GWP is supporting the development and implementation (through investment planning) of climate change adaptation plans in a number of countries and assisting them in defining their Intended Nationally Determined Contributions (INDCs) in light of the Paris Agreement.

Facilitating transboundary cooperation: GWP continued to facilitate and influence key processes and investments in support of African transboundary river basin authorities. The first three years of the strategy included implementation of the European Commission funded SITWA (Strengthening Institutions for Transboundary Water Management in Africa) and water for growth and poverty reduction in the Mekrou transboundary river basin projects.

**Contributing to the 2030 Agenda for Sustainable Development:** GWP mobilised support for a Sustainable Development Goal (SDG) dedicated to water and this was adopted in 2015. GWP built on this work by launching the SDG Preparedness Facility, targeted at country level, as well as through collaboration with UN-Water in the monitoring of water and sanitation-related SDG targets.

#### Results in knowledge and communications

**Strengthening knowledge management:** Recommendations made following major reviews of GWP's knowledge practice have been adopted, resulting in a new Knowledge Management Approach. A series of *Impact Stories* have been published which link GWP's work to tangible socioeconomic benefits. The GWP IWRM ToolBox has undergone substantial review, providing a comprehensive and up-to-date framework for integrated planning and knowledge exchange.

Collaborating across the network and with global partners: GWP's network-wide 2015 Water Goal campaign, organised in support of a dedicated water SDG, demonstrated the benefits of a coordinated effort by GWP regions anchored in a global process and supported by communication training. Collaboration with UN-Water highlighted the advantages of building on complementary strengths.



#### Results in strengthening partnership

Managing the network: An annual assessment exercise for each Regional Water Partnership is now operational and summarises performance against key criteria. This strengthens network governance in a number of ways, including compliance with donor requirements. One successful example of this due diligence is the pass in 2016 of the five pillars of the European Commission Pillars Assessment. Also, GWPO carried out two self-assessments 2016 (one for Sida and the other for the Netherlands) both of which were received positively.

**Raising funds locally:** Reducing dependency on globally sourced funding has been an objective since before the start of the current Strategy. Large variations remain between regions, in 2015, EUR 4 million was raised locally, up from EUR 2.3 in 2014, and down in 2016 to EUR 1.3 million.



#### Key water governance outcomes influenced by GWP in 2016

- Endorsement of more than ten investment plans and strategies for the implementation of climate adaptation plans (Tunisia and Zimbabwe), water sector reform (Tajikistan), and integrated water resources management at different scales (North Africa and China).
- Establishment of climate resilient governance frameworks, and the incorporation of priority actions from the national adaptation plans of Cameroon and Burkina Faso into the Nationally Determined Contributions (NDCs) and the National Programme for Social and Economic Development, respectively.
- Adoption of almost 20 IWRM-based agreements and legislative frameworks, including the legal validation of groundwater regulation in Shaanxi Province, China, and a trilateral agreement on protecting the Upper Prut River in Ukraine.
- **Strengthening of institutions** through formal governance reform policies and adopted institutional frameworks within, for example, the Palestine Water Authority.

Also, around **90 national government institutions** received direct support to governance processes.

#### 20 years of impact

The year 2016 marked 20 years since GWP began its commitment to helping governments take a cross-sectoral approach to water resources management. The 20th anniversary sparked plenty of activity, with the launch of a social media campaign anchored in an animated video. The video amassed more than 40,000 views in the first ten weeks.



#### New knowledge

More than 80 new knowledge products were produced in 2016, including the following:

- Perspectives Paper entitled *Increasing Block Tariffs: Decoupling water charges from the* provision of financial assistance to poor households
- Background Paper entitled Increasing Water Security: Key to Implementing SDGs
- Perspectives Paper entitled Linking ecosystem services and water security – SDGs offer a new opportunity for integration.
- Documentation of drought management in Eastern Africa
- Five new tools released from GWP-WMO Associated Programme on Flood Management
- Private sector participation in water sector reform in the State of Palestine
- Socioeconomic analysis of the sectoral impact of the 2014 drought in Central America.



#### **GWP's SDG Preparedness Facility**

In 2015, GWP launched the SDG Preparedness Facility to help countries prepare for implementation of the water-related SDGs. The Facility also forms a basis for building alliances with implementing partners. In 2016, the first cohort of 16 Country Water Partnerships spread throughout ten of GWP's 13 regions were selected to submit draft project notes.





#### Youth engagement: Learning from their peers



Since GWP adopted its youth engagement strategy in 2015, there have been significant advances in GWP's long-term commitment to support young water professionals. For example, with the World Youth Parliament for Water (WYPW), Water Youth Network (WYN), and L'Office franco-québécois pour la jeunesse (OFQJ), and many others, GWP facilitated the drafting of a white paper presenting recommendations by youth on climate change action for the United Nations Framework Convention on Climate Change (UNFCCC) COP21 in Paris

in 2015. As a follow up, in 2016 GWP launched a competition to support youth in leading and organising water management activities that help communities as well as developing capacity and skills. GWP also organised a session during COP22 to take stock of the present situation and devise a roadmap for future activities.

In addition, GWPO's internship programme prepares young people for professional work in water resources management. In 2016, the total number of intern days at GWPO were 930 – the equivalent of nearly 4.5 full-time positions!

#### Women and water: Education builds empowerment

In recognition of the crucial, yet often unacknowledged, role of gender issues in water resources management, GWP adopted a gender strategy in 2014. In the first two years after the launch, GWP has improved gender mainstreaming in many of its activities and across its network, supporting specific processes and opportunities.

#### Women tackle water scarcity in Central America

GWP Central America organised rainwater harvesting workshops in El Salvador and Honduras targeted at women from the six countries of Central America. The women had previous experience in management and were leaders in their communities. The training included a theoretical part and practical sessions, where the women learned to construct a rainwater harvesting system. "Women are the ones who haul the water...making sure there is water for the family," said one participant. "Now we can rest!" Another added: "This inexpensive project could help many families," going on to say that the installation was so easy, everyone should be able to do it.



The catalytic role played by GWP's multi-stakeholder network in improving water governance could not be more relevant given that "water crises" has featured among the top-ranked global risks for the past seven years (according to the World Economic Forum Global Risks Report). We need to be stewards of the planet to ensure the future of our children and grandchildren. At GWP, with two decades of experience in water governance, we are working toward that sustainable future with a multi-stakeholder partnership focused on holistic solutions to deliver water security.



#### **Finance**

#### Globally raised income

The number of financing partners channelling core funds through GWPO during 2016 were 11 (10 during 2015). The donors, Austria, China, Denmark, European Commission, France, Germany, Netherlands, Sweden, Switzerland, UNDP, and United Kingdom contributed a total of €11.1 million (€11 M 2015) in core funding.

#### Locally raised income

The regions and countries are encouraged to raise their own funds. During 2016, €1.3 million (€4.1M 2015) was raised by the regions/countries. In some cases, locally raised funding might be designated as globally raised because GWPO signed the agreement with the donor, but it was the the region or country which secured the funding. For example, the Drin Project, funded by UNDP, is a project initiated by GWP Mediterranean.

#### In-Kind contributions

The income reported in the Annual Financial Report does not include funds provided in-kind from governments, organisations or individuals. Nevertheless, in-kind contributions are gratefully recognised as a substantial source of funding. GWPO received in-kind contributions from France at an estimated value of €120,000 during 2016 as well as approximately €1 million from other sources. GWP Regional Water Partnerships reported in-kind contributions €2.6 million during 2016 (€4.2M 2015).

#### Globally raised designated income

Funds for designated activities were provided by the financial partners, European Commission, UNDP, and UNICEF. The activities at regional, country level, and global level accounted for €1.7 million during 2016 (€1.9M 2015).

# **Future Development**

As a response to the emerging development environment, a changing donor landscape, and a series of recommendations arising from major reviews of GWP, GWP adopted in 2016 a forward-looking, network-wide "Change Agenda." The overall focus is to make GWP fully able to respond to the 2030 Development Agenda. The GWP Change Agenda aims to:

- 1. Strengthen the country level
- 2. Improve the sustainability of financing
- 3. Improve corporate knowledge management
- 4. Increase institutional performance

These aims are now incorporated into the 2017-2019 Work Programme and the 2017 Annual Plan. The 2030 Agenda will drive GWP actions with a strong focus on implementation. The current GWP Strategy Towards 2020 is fully compatible with the associated goals and targets of Agenda 2030. In particular, the renewed focus on IWRM through SDG target 6.5 combined with the means of implementation set out under SDG 17 and the linkages that water provides to other goals, provides a historic opportunity for GWP to contribute to making the world water secure. This is reflected in the workplan's prominent emphasis on IWRM and holistic water governance as a means of achieving the SDGs and water security.

The Work Plan 2017 reflects confirmed income of €12.7m, with another €1m pending final confirmation.

#### Notes

#### Accounting principles

The Annual Financial Report is prepared based on the principles of going concern and accrued accounting.

Generally accepted accounting principles in Sweden are used except for fixed assets and the currency rate fluctuation reserve (see below). The accounting principles applied are unchanged compared to 2015.

#### Currencies

The GWPO accounting currency is Swedish Kronor. EURO is used for reporting purposes. The exchange rate SEK/EUR ruling at the balance date is used for all assets and liabilities.

Expenditures are converted to EURO using the average quarterly rate, if the main part of the budget-line is accounted for by the GWP Network. If the main part of the budget-line is accounted for by the Secretariat in Stockholm, the conversion is made using the exchange rate prevailing on the 25th of each month.

#### Income Statement

Income and expenditures are disclosed according to their functions.

#### **Income**

Income is accounted for on an accrual basis.

**Globally raised income** are unrestricted contributions to be used by GWPO within the GWP Strategy and Work Plan.

Globally raised designated income are contributions where specific requirements, programmatic and /or geographical, are set by the donor.

Income for designated activities above the level of expenditures for the financial year are reported as advance payments.

Locally raised income are contributions raised by the Regional & Country Water Partnerships (RWP & CWP). The agreements are between the donor and the RWP/CWP and the disbursements from the donor are deposited in the RWP/CWP's bank account. The income is reported up to the level of expenditures. In addition to the reported income of 1,345,869 Euro, disbursements of Euro 4,315,232 have been received by the RWP/CWPs to be utilised during 2017 and onwards. Locally raised income is audited in accordance with the donor requirements or GWP audit requirements.

#### In-kind contributions

In-kind contributions are, per Swedish accounting principles, not to be reported in the Income Statement. An estimate of received in-kind contributions is given in the Executive Summary.





#### Pension costs

Pension premiums for international staff, calculated as a percentage of gross salary, are deposited semiannually at AMFIE (Association Mutualiste des Fonctionnaires des Organisations Intergouvernementales, Luxembourg). A provision of EUR 29,594 is reported as liability for premiums not paid by 31st December 2016.

Pension premiums for taxed staff, calculated as a percentage of gross salary, are paid monthly to the insurance provider.

#### Leased assets

All lease agreements, regardless of whether they are financial or operating in nature, are accounted for as rental agreements (operating lease agreements).

The leasing fee is expensed over the full period of the lease on a linear basis.

#### Fixed assets

GWPO records purchase of office equipment as expenditures during the purchase year.

Office equipment of EUR 30,530 (2015 EUR 21,692) has been recorded as expenditures in 2016. Accumulated purchase value since 1 July 2002 is EUR 459,104, out of which office equipment of EUR 258,612 is still in use.

#### Receivables

Based on individual assessment, receivables are reported at the amounts which they are anticipated to be received.

#### Liabilities

Liabilities are reported at their nominal amounts.

#### Equity

GWPO keeps a Reserve Fund as restricted equity. The Reserve Fund may be used in the event of a sudden and unforeseen closedown of GWPO. The amount is approved by the GWPO Steering Committee in connection with the approval of the coming year's budget. The reserve fund shall be within the available equity.

#### Currency rate fluctuation reserve

The reserve was introduced 2005 as a facility to overcome distortions caused by fluctuations in the exchange rate SEK versus other currencies kept by GWPO. The reserve cannot show a negative value and can only include gains and losses on bank balances.

#### Cash flow statement

The statement is prepared in accordance with the indirect method. The cash flow only includes transactions which generated ingoing or outgoing payments.

#### Report on the annual accounts

#### Opinion

We have audited the annual accounts of Global Water Partnership Organisation for the year 2016.

In our opinion, the annual accounts have been prepared in accordance with generally accepted accounting principles in Sweden with the exception of BFNAR 2012:1 (K3) and the accounting of fixed assets, and present fairly, in all material respects, the financial position of the organisation as of 31 December 2016 and of its financial performance and cash flow for the year then ended. is also in accordance with generally accepted accounting principles in Sweden with the exception of accounting of fixed assets. The statutory administration report is consistent with the other parts of the annual accounts.

#### Basis for opinion

We conducted our audit in accordance with International Standards on Auditing (ISA) and generally accepted auditing standards in Sweden. Our responsibilities under those standards are further described in the Auditor's Responsibilities section. We are independent of the organisation in accordance with professional ethics for accountants in Sweden and have otherwise fulfilled our ethical responsibilities in accordance with these requirements.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinions.

#### Other Information than the annual accounts

The Steering Committee and the Executive Secretary are responsible for the other information. The other information comprises "GWP in action – 2016 annual report" and "GWP Annual Progress Review for 2016 – Mid strategy".

Our opinion on the annual accounts does not cover this other information and we do not express any form of assurance regarding this other information.

In connection with our audit of the annual accounts, our responsibility is to read the information identified above and considered whether the information is materially inconsistent with the annual accounts. In this procedure we alto take into account our knowledge otherwise obtained in the audit and assess whether the information otherwise appears to be materially misstated.

If we, based on the work performed concerning this information, conclude that there is a material misstatement of this other information, we are required to report that fact. We have nothing to report in this regard.

#### Responsibilities of the Steering Committee and the Executive Secretary
