



SDG 6.5.1 global results from last reporting round

Global IWRM average in 2020 = 54% (+ 5% since 2017)





Financing: the lowest scoring section of indicator 6.5.1 Improved capacity to absorb and disburse funde

Improved management of existing funds

Improved financing = more funding?

Advocacy

Coordinated finance planning for different waterrelated challenges

Legal and regulatory frameworks to support budget allocation and revenue raising

Improved accounting

Supporting actions in financing

- > Increasing direct central government investment backed by good policy;
- Raising revenue from traditional and non-traditional water and ecosystem services;
- > Transparency, anti-corruption and accountability;
- Leveraging opportunities from recovery support packages (COVID-19, natural disasters), using IWRM coordination mechanisms;
- Improve coordination and prioritization of funds across "sectors", identifying win-win investments, for example climate adaptation and poverty reduction;
- > Increase and improve coordinated investments from donors and banks.
