Aims and Objectives:

The overall objective of the project is to contribute to the achievement of the provisions of Art. 24 of the Revised Treaty of Basseterre, so that each Member State implements the St George's Declaration of Principles for Environmental Sustainability which seeks to achieve the long-term protection and sustained productivity of the region's natural resource base and the ecosystem services it provides.

The specific objective of the project is to improve the region's natural resource base resilience to the impacts of climate change, through effective and sustainable land management frameworks and practices and through specific adaptation pilot projects focused on physical infrastructure and ecosystems.

Expected Outputs:

- Conduct a survey to assess the status of the OECS's and the Member States' institutional, technical and human capacity
- Undertake policy dialogue on SLM (consultations, seminars)
- Develop and support adoption of harmonised legislation for SLM
- Enhance capacity of the OECS Secretariat to define, support and coordinate SLM policies and /or strategies at regional level
- Develop national land policies and implementation strategies for select Member State
- Put into operation the institutional mechanisms established in the national and regional land policies and strategies
- Develop base maps to determine land capability (including geotechnical, hazard maps) and support land use planning.
- Develop and support adoption of national, thematic, and or spatial land use plans based on land capability, risk reduction, development pressures, coastal area management issues, conservation targets, agricultural production forecasts, sustainable resource use and other relevant issues.
- Technology upgrades: Procurement of new and / or updated tools and equipment (surveying and monitoring equipment, GIS, AUTOCAD and other appropriate software and hardware, stream flow monitoring tools and equipment, cartography equipment)
- Training to support land use planning and decision making
- Develop and implement a comprehensive PA Strategy and Action Plan on SLM
- Implement appropriate Public Awareness Campaigns at national and regional levels.
- Produce and distribute mass media products in support of the PA campaigns
- Demonstration projects in each participating Member State in support of SLM (e.g. coastal protection, ecosystem restoration / rehabilitation, soil conservation, reforestation, flood mitigation, land and river bank stabilization, water conservation)
