# Integrated Water Resources Management (IWRM) Projects and Initiatives in the Caribbean

**Title:** Reduce Risks to Human and Natural Assets Resulting from Climate Change (RRACC) Project

**Organisation:** Organisation of Eastern Caribbean States (OECS)

## Aims and Objectives:

The RRACC Project evolved after a series of one-day stakeholder meetings in July 2010 on Climate Variability, Change, and Adaptation in the Caribbean region with individuals from national governments, nongovernmental organizations, the private sector, and donor agencies. It draws from regional and national climate change plans and addresses high priority vulnerabilities in sectors key to the region's development and economic growth, while identifying specific interventions that could contribute to greater resilience in the Eastern Caribbean.

The RRACC project focuses on four component areas:

- 1. Improving the enabling environment to build understanding and support for policies and laws that reduce vulnerability to climate stresses
- 2. Launching interventions in freshwater and coastal management to build resilience and demonstrate results
- 3. Building institutional capacity and addressing information gaps through support for key practitioners in government and related sectors affected by climate change as well as support for institutions in the region such as training facilities, government departments and entities charged with developing data.
- 4. Building awareness of the public on issues related to climate change and improving capacities for climate change adaptation.
