#### **Background and Context**

States are the most important actors for addressing climate change at a global level, but there are risks that their actions, designed to address local challenges, may result in additional challenges in neighbouring states, especially in transboundary basins where resources such as water may be shared. This is especially important in Africa, where close to 80% of freshwater resources (whether groundwater aquifers or surface waters) are transboundary in nature.

The initiation, and use, of transboundary organisations to foster knowledge generation and provide a platform for discussion for basin states about shared resources is not a recent phenomenon, with organisations such as the Niger Basin Authority been set up in 1964. But across Africa, transboundary organisations have had varying levels of success in meeting their differing mandates, and face ongoing challenges such as resourcing.

As climate change exacerbates challenges already inherent in Africa's hydrological cycle, and affects different parts of a watershed differently, it is clear that there is a need to highlight the importance of transboundary perspectives in adaptation and decision-making, and to support efforts to include these within states planning and actions, including finance activities.

### Objectives of the event

The objective of this event is to highlight the importance of considering transboundary perspectives when developing strategies and actions, such as through National Adaptation Plans, designed to address climate change, highlight the importance of transboundary organisations, and .

Globally, but especially in Africa, climate change holds severe implications for transboundary planning and actions, whether for surface water or groundwater.
