Project Brief

- Financed by ADA Implemented by GWP-Med in partnership with UNECE
- SEE-wide Regional Component 2017-2019
- Focused activities in:
 - Transboundary basins of Drin and Drina rivers
 - Albania
- Promote the Nexus approach in SEE catalyse related actions
 - Enhanced capacities and raised awareness
 - Assessments to identify interlinkages across sectors and investigate key ones
 - Policy Documents ("Nexus Roadmaps")
 - > Development of Project Documents for identified priority interventions
 - > Based on findings of Assessments, SAPs, related Strategic Documents



Nexus Assessment in the Drin basin

- Under the Drin Coordinated Action Process Guided by the Drin Core Group
- Following up on Drin TDA Assisting implementation of SAP
- The (Phase II) Nexus Assessment :
 - Integrated water-energy model to explore scenarios on the impact of HPPs' operation on floods management and comparison of related damages
 - Sustainable biomass and forestry: mapping of uses, interlinkages and related indicators leading to suggested solutions, in line with SAP



Nexus Assessment in the Drina basin

- Following-up on UNECE-led Nexus activities
 - (Phase I) Drina Nexus Assessment (2016-2017)
 - Drina Nexus Follow-Up Project (2018-2019): information exchange; sediments and erosion; flow regulation & environmental flows; sustainable energy
- The (Phase II) Nexus Assessment :
 - multi-country integrated water-energy model to explore developmental scenarios on the future of RES, and hydro in particular
 - key aspects of flow regulation in the basin progress towards formalizing some of these aspects
- Guided by ad-hoc SC representatives of key related institutions across sectors and borders



The Drin Strategic Action Programme (SAP)

- Endorsed by Riparians' Authorities in April 2020
- 7 Goals resulting from Drin MoU:
 - 1. Access to data to understand state of environment
 - 2. Sustainable use of water and supported ecosystems
 - 3. Cooperation to minimise risks of disasters
 - 4. Improved solid waste management
 - 5. Decrease pollution from wastewater and agriculture
 - 6. Decrease pollution from hazardous substances
 - Minimize effects of interventions on hydrologic system and supported ecosystems



The Drina Strategic Action Programme (SAP)

- In draft form, anticipated to be endorsed
 - prepared under the GEF "West Balkans DRBM Project"
- Structured around 4 Priority Areas:
 - 1. Water Quantity Management
 - 2. Water Quality Management
 - 3. Biodiversity
 - 4. Adaptation to Climate Change
