



Sustainable Production of Biomass

Legal framework

- Renewable Energy Directive of the European Union (Directive 2009/28/EC)
- Implementation into national legislation by
 - Biofuel Sustainability Ordinance (Biokraftstoff-NachV/2009)
 - Biomass-Energy Sustainability Ordinance (Biomassestrom-NachV/2009)
- Fuel Quality Directive of the European Union / Kraftstoffqualitätsrichtlinie
 - Implementation through replacement of bioful quota by GHG quota as from January 2015



Legislation and support programs

Sustainable use of hydropower energy

- → function of water-dependent ecosystems
- → improvement measures without significantly impairing usage

Legal framework

- EU Renewable Energy Directive
- EU Water Framework Directive
- Federal Water Act, Art. 34 and 35
- Federal Renewable Sources Act

Guidelines for Sustainable Hydropower Development

Mandate

- Danube Declaration 2010 / ICPDR
- Action Plan of the EU Danube Strategy, Priority Area 2

Process

- Broad participative process with involvement of representatives from administrations/institutions (energy and water/environment), hydropower sector, NGOs and scientific community
- Exchange: 4 expert meetings, 1 workshop, final conference

Basis

- Assessment Report on Hydropower Generation in the Danube Basin
- Based on replies of Danube countries on questionnaire
- \rightarrow Guiding Principles, incl. case studies and good practice examples
 - → Practical Information / Support for sustainable solutions



Cross-sectoral Strategies

- National Strategy of Sustainable Development (2002)
 - Progress reports 2008 / 2012 ...
- Integrated Environment Program (BMUB-Strategy/Work in progress)
