### 1.0 Background

In November 2010, during the 3rd Africa Water Week, the extra-ordinary session of the African Ministers' Council on Water (AMCOW) adopted a decision recommending that the Global Water Partnership (GWP) and partners operationalise the Water, Climate and Development Programme (WACDEP). The programme was developed as response to the January 2009 AMCOW request for GWP to support the implementation of the 2008 African Union Sharm el-Sheikh Declaration on Water and Sanitation.

The WACDEP aims to integrate water security and climate resilience in development planning processes, build climate resilience and support countries to adapt to a new climate regime through increased investments in water security. By building climate resilience, the initiative will contribute to peace building and conflict prevention, support pan-African integration and help safeguard investments in economic development, poverty reduction and the Millennium Development Goals (MDGs). The programme responds directly to the commitments expressed by African Heads of State in the Sharm el-Sheikh Declaration on water and sanitation.

The WACDEP supports implementation of AMCOW's triennial work program for 2010-2013 Initially, WACDEP will be implemented in eight countries: Cameroon, Ghana, Burkina Faso, Mozambique, Zimbabwe, Burundi, Rwanda and Tunisia; and four river basins: Volta Basin, Lake Chad, Lake Victoria-Kagera, and Limpopo Basin and 1 Transboundary aquifer-the North Western Sahara Aquifer System.

**The goal** of the programme is to promote water as a key part of sustainable regional and national development and contribute to climate change adaptation for economic growth and human security.

**The overall objective** is to support integration of water security and climate resilience in development planning and decision making processes, through enhanced technical and institutional capacity and predictable financing and investments in water security and climate change adaptation. **The expected outcomes** are;

- Water security and climate resilience integrated in development planning and decisionmaking processes
- Capacities of partnerships, institutions and stakeholders enhanced to integrate water security and climate resilience in development planning and decision-making processes
- "No regrets" investment and financing strategies for water security, climate resilience and development formulated and governments begin to implement them. In addition, fundable projects (infrastructure-related) for water security, climate resilience and development defined and shared with development banks

WACDEP was launched at the 2011 Stockholm World Water Week. Programme implementation began in July 2011 with an inception phase to introduce the programme at regional and country level and also define key actors and priority activities for detailed implementation from 2012 onwards.

## 2.0 Workshop format and structure

To catalyse exchange of lessons, knowledge sharing and technical coordination of WACDEP implementation among the GWP regions – Technical Coordination Workshops are convened as part of the WACDEP programme. The 4th WACDEP Coordination workshop will be held in Pretoria, South Africa from 28 January to 01 February 2013. The format of the workshop will involve the following key meetings:

#### 2.1 WACDEP Africa Programme meeting (28 and 29 January)

During the inception phase, the WACDEP Work Packages and high level TORs were defined. On the basis of these TORs, GWP regions have developed WACDEP implementation plans to guide implementation of the programme at regional and country level. A number of activities are taking place in the regions and countries now aimed at delivering the planned activities in the implementation plans. This workshop comes at a time when the growth budget tor GWP has been approved – meaning programme implementation has to be scaled up.

GWP is a network that has its partners as its base – therefore the involvement of partners in the implementation of programmes is an important facet. Careful planning is needed to see that this has been achieved in the implementation of WACDEP in Africa.

This workshop will therefore focus on sharing progress, lessons and experience gained during the initial implementation of the WACDEP regional/country work plans with an

emphasis on WACDEP implementation structures and involvement of GWP partners in the programme especially at country and local level.

In addition to programmatic issues, the workshop will also discuss financial issues for the programme looking at the process for approval of WACDEP budget allocations for countries/regions and guidelines for WACDEP financial and narrative reporting. The workshop will also look at issues of Monitoring and Evaluation, Gender Mainstreaming, Knowledge Management and Communications to see how these can be strengthened in the implementation of WACDEP.

Specifically, the workshop will:

- Share lessons on progress on the implementation of the WACDEP in the countries and regions
- Revisit the M&E plans to ensure that countries and regions have aligned with final agreed indicators within the DFID Water Security Programme
- Initiate discussions on the development of a WACDEP Communications and Knowledge Management Strategy
- Follow-up on rolling-out gender mainstreaming in the implementation of WACDEP
- Discuss and initiate development of plans aimed at involving GWP partners in the implementation of the WACDEP
- Review current budget allocations and discuss the final approved WACDEP budgets and financial guidelines

### 2.2 Reference Group Kick-off Meeting (29 January)

During the preparation of the Framework for Water Security and Climate Resilience Development, an Expert Panel was set up to provide expert advice to the development of the Framework. The Expert Panel has now been transformed into a Reference Group for the WACDEP. The RG will this be a formal structure of the WACDEP.

The WACDEP Reference Group will provide demand driven technical oversight and support to the implementation of the Programme. The WACDEP RG served as the Expert Panel in the development of the Framework for Water Security and Climate Resilient Development and will now continue to support the implementation of the Framework as well as other components of the WACDEP as a whole for the.

The 1st RG Kick-off meeting is focused on ensuring that RG members in the GWP regions and the RG members have a common understanding on their role during the implementation of the Programme. Working modalities and expected outputs for the RG will be discussed.

The RG Kick off will be combined with an inception workshop involving GWP, CDKN, AMCOW and UNDP-Capnet on implementation of the Framework for Water Security and Climate Resilience Development- AMCOW Capacity Development

#### 2.3 WACDEP Training on Financial Management (29 January)

Facilitated by GWPO, the training will enhance understanding on WACDEP financial management. Required participants will include WACDEP Regional Programme and finance Managers/Officers, WACDEP Country Programme Managers/Officers, CWP Chair or , CWP Coordinator for each WACDEP country.

#### 2.4 CDKN/AMCOW WACDEP Capacity Development Inception (30 January)

GWP is working with its partners CDKN and CapNet to implement Work Package 7 on Capacity Development in the WACDEP. CDKN is providing technical assistance in building capacity within the 8 pilot countries that GWP is implementing the WACDEP.

An international consultant with local experts from each of the 8 WACDEP counties has been identified to develop modules and deliver the training in the 8 countries over 2 years as part of the WACDEP. The aim of the 1-day Kick-Off workshop is to discuss the proposed implementation plan for the roll-out of the capacity development in the 8 countries and find ways of increasing synergies with the GWP partners, RWPs and CWPs. The RG will also attend this meeting as they will oversee the quality assurance of the materials and delivery of the programme.

The CDKN supported the first step in operationalizing WACDEP through the development of the Framework for Water Security and Climate Resilient Development. The Framework and supporting Technical Background Document provides a tool that serves as a reference document to countries in developing "no or low regrets" investments and financing strategies to achieve water security and climate resilience and integrating these into development planning processes. The Framework is aimed at senior professionals and decision makers who are responsible for making investment decisions, or may be influential to the integration of water security and climate resilience in national development planning, budgeting and investment planning. This includes ministerial advisers, senior policy makers, development planners and sector specialists.

The WACDEP programme is being implemented in 8 countries and 5 shared basins. The programme consists of four outputs and eight work packages, one of which is capacity development. CDKN has committed to contribute to the capacity development work package through support to implementation of the Framework.

This capacity development work package to which this project relates aims to strengthen the institutional capacity of planning departments in ministries, local government and broader (see target audience below) in 8 countries across Africa to apply the Framework to their real life programmes and projects. The output will be enhanced institutional capacity to develop water-related development decisions, plans and investment strategies that are no/low regrets, i.e. they are water secure and are not affected by, or will give acceptable returns, under future climate change.

The capacity development will be based around the concept of action learning.

A combination of workshops, group work, on the job tasks, and on the job coaching and support, some of which may be given in-office is envisaged. Workshops are an important aspect of a course to create a community of practise amongst the participants, but the focus should not be solely on these but include building and strengthening institutional capacity for water security and climate resilient development. An integrated delivery method using alternative methods to capacitate is also encouraged. Capacity should be built across the lifecycle of project development, from understanding the problem and identifying and appraising options, to delivering solutions and monitoring, as outlined in the Framework.

In August 2012 – CDKN made a call for an international supplier to help in supporting the In December 2012 NIRAS, in association with SIWI, Acclimatise and SMHI were appointed by CDKN as the consultants to deliver the AMCOW Capacity Development: Building capacity in water security and climate resilient development decision making.

#### **Objectives of the Kick-Off Meeting**

- 1. To deepen the understanding of all key partners in the aims and objectives of the project
- 2. To clarify the roles and responsibilities of different partners (at all levels)
- 3. To provide input and comments to the draft Inception Report for the project
- 4. To clarify implementation modalities and ensure there is a clear understanding of how the project will roll-out in the 8 countries

### 2.4 Training Workshop- Framework for Water Security and Climate Resilient Development (*31 Jan-1 Feb*)

#### Objectives:

- To enhance understanding and appreciation of the concepts and methods in the Technical Background Document for the Framework TBD)
- To ensure regions and countries can apply concepts and tools in the implementation of the WACDEP

#### **Proposed Outline:**

The workshop will be structured around the four phases of the Framework. The HR Wallingford team who are conducting the training will engage with the participants before the workshop to enable case examples or similar to be brought to the workshop for use in group sessions.

The workshop will be interactive and rely on presentations, breakout groups, discussion sessions and worked examples. As part of the workshop participants will develop ideas and an action plan as to how they can raise awareness and an understanding of the framework/TBD by grounding it in the own regional / country contexts.
